Notes on Contributors

WILLIAM M. AIRD

William M. Aird lectures on Medieval History at Cardiff University, Wales. He was awarded a PhD by Edinburgh University in 1991. With a particular interest in the history of the Normans in the 11th and 12th centuries, he is the author of *St. Cuthbert and the Normans. The Church of Durham, 1071-1153* (Woodbridge, 1998) and *Duke Curthose of Normandy, 1087-1134* (Woodbridge, 2008). His current research concerns the medieval *Life of St. Margaret of Scotland*.

JEAN-FRANÇOIS BERDAH

Jean-François Berdah was member of the *Casa de Velázquez* (“École des Hautes Études Hispaniques” in Madrid) in 1992-1994 and was awarded a PhD in Paris XII University in 1996. He has been Associate Professor in Contemporary History at the University of Toulouse II, Le Mirail, since 1998. He is director of the Centre of Excellence Jean Monnet, dedicated to European studies since 2001, and Editor-in-Chief of the *Nordic Historical Review* (“Revue d’Histoire Nordique”) founded in 2005. His research is mainly based on European comparative history, with special regard to Spain, Germany, France, Britain, but increasingly to other countries, in particular the Scandinavian and Baltic countries. His PhD research was on the Spanish Republic and the great powers, 1931-1939 and has been published in French and Spanish.

IOAN-MARIUS BUCUR

Ioan-Marius Bucur is professor of history at Babeş-Bolyai University, Cluj-Napoca, Romania. He was awarded his PhD in 2003 for a thesis *Din istoria Bisericii Greco-Catolice Române. 1918-1953* [On the History of the Romanian Greek-Catholic Church. 1918-1953] published the same year. In 2005 he published, together with Lavinia Stan, a second edition of *Persecuția Bisericii Catolice din România* [The Persecution of the Catholic Church in Romania]. His teaching and research interests relate to the religious policies of the communist regimes and the role played by religion in international relations after 1989.

IONUȚ COSTEA

Ionuț Costea is professor of history at Babeş-Bolyai University, Cluj-Napoca, Romania. He was awarded his PhD in 2004 for a thesis titled *Solam Virtutem et Nomen Bonum. Nobilitate, etnie, naționalim în Transilvania secolului al XVII-lea* [Nobility, Ethnicity and Nationalism in Transylvania in the 17th century] published in 2005.

His latest book is *Lazăr de la Rusca. Mitbiografia în comunism și post-socialism* [Lazar of Rusca. Mythbiography in Communism and Post-Socialism] published in 2008. His teaching and research interests lie in cultural history, biography and oral history.

ELENA-MIRELA CIUCHEA

Elena-Mirela Ciuchea graduated from the “Stefan cel Mare” University in Suceava and completed a Masters in Modern and Contemporary History and also a Masters in Human Resource Management. She is now a doctoral student working on the Romanian interwar politician, Constantin Argetoianu, on whom she has recently published two articles.

STEVEN G. ELLIS

Steven G. Ellis is Professor of History at the National University of Ireland, Galway. He took his BA in History at Manchester University where he was also awarded his MA for a thesis on ‘The Kildare rebellion, 1534’ before moving to the Institute of Irish Studies, Queen’s University, Belfast. He received a PhD there for a dissertation which was subsequently revised and published as *Reform and Revival: English government in Ireland 1470-1534* (London 1986) and was awarded a DLitt in 1988 by the National University of Ireland for his research on late medieval and Tudor Ireland. He joined the History Department in Galway in 1976 and teaches mainly Irish and British history circa 1300-1700. His current research interests focus on British state formation and frontier societies. His major books include *Tudor frontiers and noble power: the making of the British state* (Oxford, 1995), *Ireland in the age of the Tudors 1447-1603: English expansion and the end of Gaelic rule* (London, 1998), and *The making of the British Isles: the state of Britain and Ireland 1450-1660* (London, 2007).

RAINGARD EßER

Raingard Eßer has studied History, German and Education in Cologne where she also received her doctorate for research on Dutch immigrants to England in the 16th and 17th centuries. She has taught at universities in Germany and in England and is currently Reader in Early Modern History at the University of the West of England, Bristol (UK). Her main publications include *Niederländische Exulanten im England des späten 16. und frühen 17. Jahrhundert: Die Norwicher Fremdegemeinden* (Berlin 1996), *Die Tudors und die Stuarts* (Stuttgart 2004) and, edited with Steven G. Ellis, *Frontiers and the Writing of History, 1500-1850. The Formation of Europe, vol.1*, (Hanover 2006). She is currently completing a book on Netherlandish identity and the politics of memory in the 17th century.

KIERAN HOARE

Kieran Hoare received his MA in Irish History at University College Cork, Ireland, in 1993, for a thesis on “The Earldom and Supremacy of Desmond: the case study of a lordship, 1329-1583”. He is currently a doctoral student at the National University of Ireland, Galway, Ireland. His areas of interest relate to the development of an urban oligarchy in Irish towns in the 15th and 16th centuries, their interaction with Tudor state formation and their hinterlands, as well as the operation of municipal government within the towns themselves.

MIROSLAV HROCH

Miroslav Hroch is Professor of Modern History at the Faculty of Humanities and Faculty of Philosophy and Arts, Charles University, Prague. He has also been Visiting Professor at the European University Institute in Florence, at the Freie Universität Berlin and at UCLA. He specializes in the issue of nation building processes especially among small European nations. His many books include *V narodnim zajmu. Pozadavky a cile evropskych narodnich hnuti v komparativni perspektive* [In the name of the Nation. National Programmes and Demands in Comparative Perspective], Prague 1996; *Social Preconditions of National Revival in Europe*, Cambridge 1985; *Handel und Politik im Ostseeraum während des Dreissigjährigen Krieges*, Prague 1977.

ELENA MANNOVÁ

Elena Mannová is a Senior Research Fellow at the Institute of History, Slovak Academy of Sciences, Bratislava. She specializes in 19th- and 20th-century social history. Her major publications include edited volumes of *Bürgertum und bürgerliche Gesellschaft in der Slowakei 1900-1989* (1997; Slovak ed. 1998); (with Moritz Csáky) *Collective Identities in Central Europe in Modern Times* (1999; Slovak ed. 1999); *A Concise History of Slovakia* (2000; Russian and Slovak eds. 2003; Slovenian ed. 2004); (with Hannes Stekl) *Heroen, Mythen, Identitäten. Die Slowakei und Österreich im Vergleich* (2003); (with Eduard Krekovič and Eva Krekovičová) *Mýty naše slovenské* (2005). She has also published on 19th- and 20th-century voluntary associations and on the collective identities of Slovaks, Germans and Hungarians in Slovakia.

MARTIN MOLL

Martin Moll completed his studies in History and German Literature with a doctoral degree in 1987, and has since worked as an independent scholar. His main fields of interest were initially centred on the Inter-War years and on World War II. Recently he has concentrated on Habsburg history in the 19th and early 20th centuries. He became a *Universitäts-Dozent* (Professor) for Modern and Contemporary History in the His-

tory Department, Graz University, Austria. Martin Moll is the editor of Hitler's unpublished orders which appeared under the title *Führer-Erlasse 1939-1945* in Stuttgart in 1997. He also published a study on nationality conflicts in the Austrian Duchy of Styria during World War I (*Kein Burgfrieden*, Innsbruck 2007).

RHYS MORGAN

Rhys Morgan graduated in 2004 with a degree in Modern History from the University of Oxford. He is currently a doctoral student at Cardiff University. His main research interest is the importance of Wales within the early modern 'British' state and, in particular, the Welsh role in the conquest and plantation of Ireland between 1558 and 1641. His work is funded by a grant from the Arts and Humanities Research Council.

GERALD POWER

Gerald Power was awarded a doctorate by the National University of Ireland, Galway, in 2008, where he is currently teaching. His research interests concern relations between nobles and the state in the early modern period, particularly in the British Isles. His book, *A European elite: the nobility of the English Pale in Ireland, 1450-1566*, is forthcoming.

ANNA MARIA PULT QUAGLIA

Anna Maria Pult is Lecturer in Early Modern History at the University of Pisa, Italy. She has worked on economic and social history in early-modern Tuscany, on provisioning systems in early-modern Europe, and on social mobility. Her current research programme focuses on the landed estate of the Medici. Her publications include "*Per provvedere ai popoli*". *Il sistema annonario nella Toscana dei Medici* (Florence 1990), *Stato regionale e mobilità sociale: alcune considerazioni sulla Toscana tra il XVI e il XVIII secolo*, in *Ricerche di Storia Moderna IV. In onore di Mario Mirri* (Pisa 1995), *L'agricoltura*, in *Storia della civiltà Toscana*, vols. III - IV (Florence 1999 and 2003), *La viticoltura e il vino nella Toscana moderna* in *Actas del I Simposio de la Asociación Internacional de Historia y Civilización de la Vid y el Vino*, vol. I (ed. Javier Maldonado Rosso; El Puerto de Santa María 2001), *Les contrats agraires dans les domaines de Medici (XVI-XVIII siècles)*, in G. Béaur, M. Arnoux, A. Varet-Vitu (eds.), *Exploiter la Terre. Les Contrats agraires de l'Antiquité à nos jours* (Rennes 2003).

MILOŠ ŘEZNÍK

Miloš Řezník studied history in Prague, where he also obtained his PhD in 1999 for a thesis on patriotisms in Polish Prussia in the 18th century. His Habilitation at the University at Olomouc (2007) was focused on the problems of identity and elite changes

during the Polish uprisings between 1794 and 1864 (published in Prague 2006 as *Za naši a vaši svobodu. Století polských povstání*). From 1995, he was attached successively to the Foreign Ministry of the Czech Republic, the Universities of Prague and Liberec, and the Centre of Culture and History of East-Central Europe at Leipzig. Since 2002 he has been junior professor, and since 2009, professor of European Regional History at the University at Chemnitz (Germany). He is chair of the Czech section of the German-Czech Historians' Commission. He works on problems of nation-building, historical representations, regionality, and collective identities.

EWELINA SZPAK

Ewelina Szpak obtained her MA degree in History at Jagiellonian University in Krakow and is at present completing her PhD thesis there. Her research interests focus on the history of everyday life, mentalities and oral history. She has published several articles about the history of Polish peasants and Polish State Farms; her MA thesis was published as *Everyday Life of the inhabitants of Polish State Farms*, Warsaw 2005. In 2008 she was awarded by the grant funded by the Polish State Committee of Scientific Research.
